The Rood & Riddle Dowager

(Grade III)**

FOR FILLIES AND MARES, THREE YEARS OLD AND UPWARD By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$3,750 by time of entry (Includes entry and starting fees). \$625 to enter and an additional \$625 to start, with \$125,000 guaranteed, of which \$75,000 to the owner of the winner, \$25,000 to second, \$12,500 to third, \$6,250 to fourth, \$3,750 to fifth and \$2,500 to be divided equally among sixth through last. Weight: Three year old fillies, 122 lbs., Older fillies and mares, 125 lbs. Non-winners of a Grade I or II over nine furlongs in 2020, allowed 2 lbs.; a graded stakes over nine furlongs in 2020, 4 lbs. The maximum number of starters for the Rood and Riddle Dowager will be limited to fourteen, with two also eligibles. If this race is transferred to the main track the field will be limited to fourteen. In the event that the race overfills the starters will be determined at that time with preference given to graded stakes winners (in order I-II-III), then highest non-restricted turf earnings in 2020. Starters to be named through the entry box by the usual time of closing. A Keeneland trophy cup will be presented to the owner of the winner.
