(Grade II)**

FOR THREE YEAR OLDS AND UP By subscription of \$100 each, which should accompany the nomination or by supplementary nomination of \$6,000 at time of entry (includes entry and starting fees). \$1,000 to enter and an additional \$1,000 to start with \$200,000 guaranteed, of which \$120,000 to the owner of the winner, \$40,000 to second, \$20,000 to third, \$10,000 to fourth, \$6,000 to fifth and \$4,000 to be divided equally among sixth through last. Northern Hemisphere Three-Year-Olds, 122 lbs.; Older, 126 lbs.; Southern Hemisphere Three-Year-Olds, 115 lbs.; Older 126 lbs. Non-winners of a Grade I or Grade II race over ten furlongs in 2020, allowed 2 lbs.; a Grade III over ten furlongs in 2020 allowed, 4 lbs. The maximum number of starters for The Thoroughbred Aftercare Alliance Stakes will be limited to fourteen. In the event that more than fourteen horses pass the entry box, the fourteen starters will be determined at that time with preference to graded or group stakes winners (in order I-II-III), then highest earnings in 2019-2020. Starters to be named through the entry box by the usual time of closing. A set of two silver julep cups will be presented to the owner of the winner.
